Dr. W. Wilson Goode, Sr.

Dr. W. Wilson Goode, Sr. is the President and CEO of Amachi, Incorporated, a nationally acclaimed faith-based program for mentoring children of incarcerated parents; and Chairman and CEO of Self, Incorporated – a nonprofit corporation dedicated to serving more than 600 homeless men and women. He is a Senior Fellow at the Fox School at the University of Pennsylvania. He became the City's first African American Mayor in 1984 and served two terms. Because of his innovative and ground-breaking work, he received two prestigious awards in 2006: the Civic Ventures Purpose Prize, and the Philadelphia Inquirer's Citizen of

the Year Award. He is an ordained Baptist Minister since 1999 with more than 63 years of service at the First Baptist Church of Paschall located in southwest Philadelphia.

Dr. Goode has served as an officer in the United States Army. He led ground-breaking work in faith-based housing, assisting churches in building more than 2,000 units for low and moderate income persons. And, he was the first African American member and Chairman of the Pennsylvania Public Utility Commission. He broke racial barriers again with his appointment as Managing Director for the City of Philadelphia. He subsequently spent 7 years as Deputy Assistant Secretary of Education in the Clinton Administration. He left that position in 2000 to organize the Amachi program which has now served more than 300,000 children in 50 States.

Dr. Goode is Chairman of the Philadelphia Leadership Foundation. He is a Board Member and Former Chairman of Big Brothers Big Sisters Independence Region, and the Free Library of Philadelphia, He is also former Chair of Partners for Sacred Places and the Cornerstone Christian Academy. He is a Board Member of America's Promise Alliance, Community In Schools of Philadelphia, and Eastern University. He is Chairman Emeritus of Leadership Foundations, and Emeritus Trustee of Southwest Leadership Academy Charter School.

Dr. Goode has earned degrees from Morgan State University (BA), the University of Pennsylvania (MA), Palmer, Theological Seminary (D. Min.), and fourteen conferred honorary doctorates. He is a member of Sigma Pi Phi Fraternity and Kappa Alpha Psi.

Dr. Goode and his wife of 56 years have one son, two daughters and two granddaughters.

Dear Dr. Lynch,

You requested that I write to explain Pennsylvania's current child welfare system, and to endorse the involvement of fathers and their families in the lives of their children.

Ten years ago, we began organizing Pennsylvania into a coherent child welfare community. We created county roundtables of involved individuals in most counties within Pennsylvania, leadership roundtables comprised of representatives from county roundtables of like-sized jurisdictions to allow joint problem-solving and system enhancement, and a state roundtable to ensure that all of Pennsylvania was working together in implementing best practices for our children. This effort was and remains coordinated by the Office of Children and Families in the Courts, lead remarkably by Sandy Moore, MSW. Through these collaborative efforts, we have reduced the number of children in foster care by about 7,000 during these ten years, and have seen a shift from congregate care and foster care to kinship care for those children remaining under state supervision.

As part of these efforts, we have recognized that fathers have the same responsibilities and, importantly, the same rights as mothers. We want them to be involved in parenting their children. Even when fathers are unable to fulfil this responsibility, we look to their families to participate in the raising of their children. We believe that to ignore fathers and their families is to disregard a large valuable resource for children.

I. Ms. Moore, and all involved in the Pennsylvania child welfare community congratulate you and your team for taking steps to enhance the involvement of fathers in the lives of their children. We look forward to working alongside you as we all strive to ensure that every child in Pennsylvania is raised by a competent and loving family member.

12 years on Capitol Hill, Lesley worked on health care, education, human services, and immigration issues in several different capacities. Auditor General DePasquale's ongoing work touches the lives of all Pennsylvanians. He is most proud of the work that led to fixing the state's childabuse hotline, ChildLine, where more than 58,000 calls went unanswered before his audit; reducing

the number of untested rape kits in Pennsylvania and across the nation; and recommending improvements in the state's response to the opioid crisis. He continues to fight to protect children from abuse, end the backlog of untested rape kits, make college affordable for the middle class, and ensure seniors have access to the services they need.

Senator Browne served as Senate Majority Whip for the 2011-12 and 2013-14 Legislative Sessions. Besides serving as Appropriations Committee Chairman, he is also a member of three Senate Committees: Education; Finance; and Health & Human Services, as well as the Senate Majority Policy Committee.

Senator Browne is Co-Chair of the bi-partisan, bi-cameral Early Childhood Education Caucus and the Legislative Arts and Culture Caucus. He is also Co-Chair of the PA Public School Building Construction and Reconstruction Advisory Committee (PlanCon) and had previously Co-Chaired both the Basic Education Funding Commission and the Special Education Funding Commission.

Senator Browne is the author of numerous state laws ranging from child protection legislation to education initiatives to reforming state government. He drafted key portions of Act 120 of 2010 which fundamentally reformed Pennsylvania's public pension systems and created an independent fiscal office to monitor state spending and the budget process. Senator Browne was instrumental in developing the Pennsylvania Web Accountability and Transparency (Penn WATCH) Act, which expanded the public's access to state spending records by creating and maintaining a searchable, database-driven budget website.

In 2009, Senator Browne crafted the one-of-a-kind, 130-acre Neighborhood Improvement Zone (NIZ) to help revitalize and expand the tax base of the then financially-struggling city of Allentown. To date over \$2 billion of new development investment in Allentown and more than \$3 million in annual school property tax revenues for Allentown School District have been generated through the zone. The NIZ has already served as a model for economic development in other distressed areas – cities, boroughs and townships – throughout the Commonwealth with the creation of the City Revitalization and Improvement Zones (CRIZ) which will afford a similar tax financing program to smaller cities in Pennsylvania.

Born and raised in Allentown, Senator Browne attended Allentown Central Catholic High School. He resides in Allentown with his wife, Heather, and son, Alex.
